Horse and rider combinations can stay at the same level throughout the Winter League.

NB. Other than the Pairs class, horses may only compete in consecutive levels.

Past 1st placed combinations may enter the same level of competition but will not be eligible to win the same league for a second time.

Run under BRC Rules

Minimum age of horses for classes 1 – 4 is 4yrs and 5 years for classes 7 – 9

Riders must be 18 years or over

Class 1 TRAINING CLASS 55-60CMS – £12: Open to inexperienced horses/riders as a training round. Help/guidance given if wanted. One round, with the option of jumping a second round, if you wish. Entrants may only enter classes 2 & 3.

Class 2 CLEAR ROUND 60-65CMS - £7 For Nursery class entries only. Jump one round.

Class 3 NURSERY – MAX 70CMS - £12: Restricted to combinations who have not been placed $1^{st} - 3^{rd}$ at any jumping competition at 80cms and above on more than two occasions. Combinations will jump one round, with penalties for knockdowns/refusals, then jump a second round over a timed shorter course.

Class 4 – PAIRS RELAY 70cms (Fancy dress optional) - £12 First member of the pair will jump round the course and will hand the baton over to the second member, who will then jump round. Each round will be timed. There is a prize for the best fancy dress pair.

Class 5 CLEAR ROUND 70CMS - £7 For Novice class entries only. Jump one round.

Class 6 NOVICE – MAX 80CMS - £12 – Restricted to combinations who have not been placed $1^{st} - 3^{rd}$ at any jumping competition at 90cms and above on more than two occasions. Combinations will jump one round and then jump a second round over a timed shorter course.

Class 7 CLEAR ROUND 80CMS - £7 – For Intermediate and Open horses only. Jump one round.

Class 8 INTERMEDIATE - MAX 90CMS - £12 - Open

Class 9 OPEN - MAX 100CMS - £12 - Open

Class 10 SUPER OPEN - HEIGHT 105-110CMS - £12 - Open. Horses will jump fewer fences.

General information

Please ensure that you do not muck out your horsebox onto parking area. Take all litter home with you. All riders and helpers must ensure that they act courteously to stewards and officials at all times.

Rudeness will not be tolerated.

Hats must be worn at all times when mounted and must comply to the current BETA Standards (see below). Hair must be above the collar and long hair secured with a hairnet.

Horses/Ponies must not be left unattended or tied to the outside of trailers/lorries

Any information given on entering will only be used for the purposes of this competition and will not be passed on to any third party.

Hat/Body Protector Rules

Under BRC rules applying to this event, all riders when mounted, whether competing or not, must wear a hard hat complying with one of the following specifications and with the strap properly adjusted and fastened. Only the following specifications are acceptable at any BRC competition

- i. PAS015 (2011) and must have official BSI Kite mark or Inspec IC mark
- ii. VG1 01.040 (2014-12) and must have official BSI Kite mark or Inspec IC mark
- iii. ASTM F1163 (2004a or 04a onwards) and must have official SEI mark
- iv. SNELL E2016 and must have official SNELL label and number
- v. AS/NZS 3838 (2006 onwards) and must have official SAI global mark
- vi. EN1384:2023 and must have BSI kitemark or Inspec IC mark

It is the rider's responsibility to ensure they are wearing hats to the correct standard. Any rider found to be using a hat to a lower specification will be disqualified. Riders should be aware that riding in a hat which is not up to the standard specified above may invalidate any insurance.

Body protectors BETA Level 3 Blue 2018 Label

The ONLY exception to the requirement for a BETA Level 3 2018 label is that Exo Body Cages will continue to be accepted, provided they have a BETA Level 3 2000 purple label. The competitor must inform the event secretary.

It is recommended that body protectors are replaced once they are more than 5 years old.
